# KEYNOTE SPEAKER



## **CHARLES M. BLOW**

Charles M. Blow is The New York Times's visual Op-Ed columnist. Mr. Blow joined The New York Times in 1994 as a graphics editor and quickly became the paper's graphics director, a position he held for nine years. In that role, he led The Times to a best of show award from the Society of News Design for the Times's information graphics

coverage of 9/11, the first time the award had been given for graphics coverage. He also led the paper to its first two best in show awards from the Malofiej International Infographics Summit for work that included coverage of the Iraq war. Mr. Blow went on to become the paper's Design Director for News before leaving in 2006, briefly, to become the Art Director of National Geographic Magazine.

Mr. Blow is a bold and empathetic thinker and his columns in the New York Times regularly reveal the stark conditions facing children and families and lay bare the policy choices confronting this country.

Mr. Blow graduated magna cum laude from Grambling State University in Louisiana, where he received a B.A. in mass communications. He lives in Brooklyn with his three children.

# THE ELEANOR ROOSEVELT AWARD



## **MICHAEL A. CORRIERO**

Michael A. Corriero is the Executive Director and Founder of the New York Center for Juvenile Justice. The Center's mission is to establish and promote a comprehensive model of juvenile justice that will treat children as children and respond to their misconduct with strategies that are designed to improve their chances of becoming constructive members of

society. As a platform for leadership, coordination, research, education and advocacy, the Center spearheads policies that secure justice for children in New York State and across the nation.

He served as the Executive Director of Big Brothers Big Sisters of New York City from 2008 to 2010 and previously served as a Judge in the New York State courts for 28 years, including 16 years presiding over Manhattan's Youth Part, a court set aside within the adult court system to deal exclusively with the cases of 13, 14, and 15-year-olds who are charged with the most serious and violent crimes.

Judge Corriero serves at the request of the former Chief Judge of New York State, Judith Kaye, on the New York State Permanent Commission on Justice for Children. He also serves on Mayor Michael Bloomberg's Committee on the Judiciary and served on the Governor's Task Force on Transforming Juvenile Justice. He has previously served on the New York State Probation Commission Task Force.

Judge Corriero is an alumnus of St. John's University School of Law (1967) and St. John's University (1964). He was a member of the Law Review and served as an associate editor. He graduated from St. John's University College with a Bachelor of Arts degree majoring in social science.

He is the author of a book entitled: *Judging Children as Children: A Proposal for a Juvenile Justice System*, published by Temple University Press, September 2006.

## **LISA PHILP**

Lisa Philp serves as Vice President for Strategic Philanthropy and Director of GrantCraft at the Foundation Center. In this newly created position, she works with foundations, donors and their advisors, and philanthropy associations, to meet their needs for custom knowledge services to increase impact and enhance effectiveness.

Lisa previously served as Managing Director and Global Head of Philanthropic Services for the J.P. Morgan Private Bank in New York. In this role, she oversaw \$100+ million in annual grantmaking by 65 foundations and, with her team, advised several hundred major donors each year.

Prior to joining J.P. Morgan in 1998, Lisa served as a Program Officer for Youth Development and Education at The Robin Hood Foundation and as Director of Communications and Government Relations at Philanthropy New York. Her additional experience includes positions at several Washington, DC-based organizations, including the American Film Institute at the Kennedy Center, the National Forum for Black Public Administrators, the National Trust for Historic Preservation, and Public Technology, Inc.

Lisa formerly served as Chair of Asian Americans/Pacific Islanders in Philanthropy, a Vice Chair of The New York Women's Foundation, and as a board member of Grantmakers for Children, Youth and Families. A frequent commentator on philanthropy matters in the press, she has also taught Master's level coursework on philanthropy as an adjunct professor at New York University.

Lisa earned an M.B.A. in marketing and nonprofit management from the Kellogg School of Management at Northwestern University and received her B.A. in Asian studies and economics from the University of Michigan. She recently completed a mid-career Revson Fellowship at Columbia University, and is pursuing a Master's degree in Interdisciplinary Studies in Education at Teachers College.

# MASTER OF CEREMONIES



## JUJU CHANG

Juju Chang is an Emmy-winning correspondent for "20/20" and "Nightline", and former news anchor for "Good Morning America." She also hosts "Moms Get Real," a digital show for ABC News NOW aimed at cracking the façade of perfect mommyhood.

Chang has covered breaking news of the devastating earthquake in Haiti and the deadly mine disaster in West Virginia. She received an Emmy Award for team coverage of the California wildfires. She won one of her two Gracies for a "20/20" story on gender equality in the sciences.

Chang's award-winning investigative reports include the case of Hannah Overton, a young Texas mother of five, sentenced to life in prison for the salt-poisoning death of her foster son Andrew Burd. She has also examined the juvenile justice system through the case of 11-year-old accused killer Jordan Brown.

From 1999 to 2000, Chang anchored the early morning newscasts "World News Now" and "World News This Morning." She began her career at ABC News as a desk assistant and eventually became a producer at "World News Tonight." She was based in Washington, D.C. from 1996-1997, where she covered the White House, Capitol Hill, and the 1996 presidential election for NewsOne, ABC's affiliate news service.

Born in Seoul, South Korea and raised in California, Chang graduated with honors from Stanford University with a BA in political science and communication. At Stanford, she was awarded the Edwin Cotrell Political Science Prize.

Chang is married to Neal Shapiro and has three sons. She is a member of the Council on Foreign Relations and a founding board member of the Korean American Community Foundation.
